#### How to apply for your free Will

You can go to any Will provider to make a Will and leave a gift to us. If you don't know where to start, would prefer to see someone locally, or would love a free Will, then we have teamed up with local solicitor Coles Miller, who can provide a Will, and Faithworks will then cover the cost.\*

To apply for your free Will contact Coles Miller by phoning 01202 338888 or write to Coles Miller Solicitors LLP of Harbour House, Marshes End, Upton Road, Poole BH17 7AG. Explain that you want to make an appointment under the Faithworks Free Wills Service.

Once you have made your Will, you will be asked to complete the form (overleaf) which will be returned to us by Coles Miller. This will enable us to measure how effective the service is.



#### \*Terms and conditions

- You (or your partner for a joint Will) must be over 50 to take part.
- Faithworks will cover the cost of a standard Will up to a maximum agreed limit.
   Non-standard Wills may incur a top-up fee which you will be required to pay –
   Coles Miller can advise on this when booking.
- In order for us to cover the cost of your Will, you must complete, sign and date
  the Free Wills Participants Form (overleaf). Coles Miller will return this form to us
  with the invoice for the costs incurred which you also need to sign and date.
- We will keep your details in line with GDPR.
- Faithworks reserves the right to withdraw this offer at any time.








Faithworks' projects include: Food Banks, CMA debt advice, support for lone parent families, and those experiencing homelessness.
